3. ALERRT Training

Capt. James Riley: gave a report on ALERRT Trainings with the local law enforcement and how it is helping the local law enforcement learn the layout of our schools.

- 4. Standard Response Protocol Implementation:
 - Raptor Panic Alert-Quickly summon help, automatically send alerts so everyone knows how to respond, text, or call 911, seamlessly switches between campuses, summon local help for fights, medical assistance, and vandalism, communicates with all users through real time group messaging
 - Drill Manager-Streamlined process, schedule all drills, manage, and review all drills
 - Reunification Management-Eliminates chaos (no more paper and pencil),
 Scans the guardians ID to check for custody/guardianship, records approved
 guardian signature, software automatically sends alerts to other guardians
 upon reunification, parent meets greeter, sent to guardian staging area,
 student runner gets alert to bring the student.

5. EOP Submission

Submitted in October. Will continue writing new annexes once we receive some feedback from TxSSC.

6. Maintenance Update:

Randy O'Bannion: Will be getting a grant. Putting a fence up around the back of Sour Lake Elementary school. The fence will be 8 foot high. The China Elementary fences will be updated to non-scalable fences. Signage will be updated on each campus in naming the hallways. Lastly, we are replacing or updating cameras on all the campuses.
