1. Call to Order

The meeting was called to order at 4:00 PM by Miracle Turner, Emergency Management Coordinator for HJISD.

2. Roll Call

- 3. Exterior Door Audit
 - a. Results- We have had three door audits so far this year and two of those audits were unsuccessful.

<u>Sour Lake Elementary</u>: Ms. Lietzke, Assistant Principal, reported that one door to the gym that has a magnetic card reader on it which Little Dribblers use in the evenings for practice, was dogged down, but it was not latched. The auditor was able to open the door with a PE class in session. The school is upgrading to a different card reader system on that door so people can still use the gym after hours. Ms. Lietzke stated that they will have training for all staff and subs.

<u>High School</u>: The outside door to the high school band hall had been dogged down. When the auditor pulled on the door he was able to open it. Mr. Trammel was standing right there and told the auditor to check in with the front office and the front office did what they were supposed to do in that situation. All other doors were locked. The high school has had additional training with all staff and subs.

- 4. Maintenance Updates
 - Mr. Decker gave a report on the maintenance updates:
 - Working on doors at SLE. New doors in old frames do not always fit correctly. All the new hardware should be installed by Christmas.
 - A lot of card readers throughout (mainly at the Jr. High) the district have gone on line during Thanksgiving break.
 - Trying to find a better solution for some of our gates.
- 5. CE Campus Update
 - The only issue has been the gates and Mr. Deckard touched on that. Everything else is great at CE.
- 6. SLE Campus Update
 - See above report under exterior door audit.
- 7. HJJH Campus Update
 - Mr. Sims, principal, reported that safety is significantly better than it was last year in the new school compared to the village. In the new building everything is swipe cards. The Jr. High campus went through the audit process early in the year and passed even with construction workers still in and out at that time.
- 8. HJHS Campus Update
